Send Letters with a Copy of a Government-Issued ID and 2 Utility Bills

Letter #2: Dispute Negative CLOSED Accounts ONLY (609 Letter)

Letter #1: Inaccurate Information

Wait 30 Calendar Days

Mail in SEPARATE Envelopes At the SAME TIME Via Trackable Mail

File a Police Report and FTC Complaint Beforehand for ID Theft (If Applicable) and Include This with Your Letters

**Prepare Your Letters to Experian, Equifax, and Transunion**

**After 30 Calendar Days**

Mail the MOV Letter via Trackable Mail to Each Credit Bureau

Wait Another 30 Calendar Days

Send Empty Envelopes via Certified Mail to Each Creditor to Collect the Signed/Dated Green Cards

**Begin the dispute process**

Include a copy of your ID and 2 utility bills with EACH letter to EACH bureau

**Always include a copy of your ID and 2 bills with EVERY letter to the bureaus but NEVER give this info to a creditor or collection agency! If you don't have utility bills in your name, use a statement from your bank, insurance company, credit card, etc. but blank out any account numbers.**
